It's been busy

- Interim Reports: Things are picking up pace. Interim reports will be published soon. Teachers will be reaching out to parents in various methods to communicate academic progress. - School Programs:
  - Auditions for Drama have occurred and they will have an orchestra in the pit!
  - Fine Arts in full swing
  - Riverside Trades Sampler 32 grade 11 and 12 students (16 per semester) spending time at Riverside College.
  - AP classes FULL (Advance Placement earning university credit). In back to back years MSS students have won \$100 000 Schulich Scholarship Award for STEM (Science, Technology, Engineering and Math)
  - MSS students score very well on provincial AP exams
  - School continues to be full at 1380 students however, new students continue to be registered as they move into the district
- Breakfast Club / funding (question asked by Melanie Janzen)
  - approx \$20 000 granted to MSS for this program. In previous years this has been topped up due to COVID grants and so forth. Now we are back down to the original \$20 000 as the COVID grant money has depleted. This means hot breakfasts have been reduced but cold breakfast of fruit, yogurt, bagels, etc, continues. Some focus on the elementary schools sandwiches are made at MSS and delivered to Mission Central and West Heights (and hockey academy players support with delivery as well as spending time with the elementary kids)
  - Meal programs for MSS students who are hungry can seek out cafe cards for sandwich, wrap, pasta

  result of failure to fulfill the agreed upon commitment. 1st Shannon 2nd Alana. Motion
  passes.
- Fundraising Christmas tree fundraiser again this year? Yvonne to investigate if the nursery is offering this fundraiser this year. Kim brought forward an option for a large scale fundraiser / raffle which could potentially bring a lot of money to PAC. Fundraiser will be used to cover Dry Grad costs with the remaining proceeds going into PAC general account to support other school initiatives.
